- 1) Payment in full must be made before TPR will finalize tutoring assignments. The cost of your tutorial course is based upon the package you select. There may be discounts available to those students tutoring for prolonged periods of time or for small-group tutorials. This payment does not guarantee that a tutor will be available. In the unlikely event that TPR is unable to assign tutors, my payment will be returned in full.
- 2) Once I have enrolled in The Princeton Review Tutorial Course, TPR will assign a tutor. For maximum flexibility, I will arrange the time and place of tutoring directly with the tutoring director. The tutoring director will call me to arrange the schedule. Although sessions will take place at a mutually convenient location, TPR cannot guarantee that tutors will be able to come to my home.
- 3) If at any time there is a problem with the assigned tutor, I will immediately call the office. If necessary, TPR will assign a new tutor.
- 4) If I am dissatisfied at any time during the program, TPR will promptly and unconditionally return my tuition on a pro-rata basis, upon written request accompanied by the return of all books and materials.
- 5) If I cancel a tutoring appointment and do not give the tutor at least 24 hours notice, one hour will be deducted from the total credit of tutorial hours on my account. If a tutor cancels an appointment and does not give me at least 24 hours notice, I will be given one free hour of tutorial. If a cancellation is agreed upon by mutual consent, no change in the number of hours will be assessed.
- 6) I have enrolled in The Princeton Review solely for the purpose of preparing for admissions tests. I acknowledge and understand that all Princeton Review materials and techniques are the sole property of The Princeton Review. I can talk about the course in general terms with others; however, I agree that I will not disclose specific course materials and/or techniques, orally or in writing, to any third party. I further agree that I will neither make copies nor distribute any of the course materials to any third party without prior written consent of The Princeton Review.
- 7) The Princeton Review provides serious courses for students who are willing to work hard to improve their test scores.
